Your privacy is important to us. Collecting personal information

We collect information from you in various ways when you use our website. We may collect personal information you directly provide on our website. In addition, we may collect personal information from you as a user of our website. Information we may collect includes a name and email address, company you work for and your website URL, your phone number, and any other information requested from you. We may supplement this information with information collected from other companies.

Cookies

Cookies are alphanumeric identifiers that we transfer to your computer's hard drive through your browser to enable our systems to recognize your browser and tell us how and when applications are visited and by how many people. We use cookies to enhance visitors' experiences, to learn more about their use of the applications and to improve the quality of our services. When you use our website, one or more cookies will be sent and stored on your computer. These cookies are used to save certain preferences and identify you on future visits. If your browser is set not to accept cookies or if you reject a cookie, you may not be able to access certain features or services of our website.

Use of personal information we collect

We use your personal information to provide you with services, to operate and improve our website, to send you messages, and for other purposes described in this Policy. For example, we may use the information we collect from you on our website:

- to personalize and improve your experience on our website;
- to conduct an aggregated analysis of the performance of promotions;
- to personalize and improve your experience on our website;
- to respond to comments and questions and provide customer service;
- to deliver service messages and other services and content you request and to send information related to accounts and services, including confirmations, invoices, technical notices, updates, security alerts, and support and administrative messages;
- to send you information about new promotions, products, and services offered by Jakov Apartments and our selected partners;
- to contact you directly and offer our services;

When you provide us with personal data by downloading our ebook(s), we keep your personal data for 60 days. After that, if you are not subscribed to our newsletter, we delete all data from our systems.

Sharing of personal information

Some promotions and features of our website are presented jointly with other companies. If you choose to participate in those promotions or use those features, your information may be collected and used by Jakov Apartments and those other companies. Use of your information by those other companies for their own purposes is not controlled by Jakov Apartments and is subject to their own terms and privacy policies. Please

We do not share your personal information with third parties other than as described above and as follows:

- with your consent, for example, when you agree to our sharing of your information with other third-party partners for their own marketing and other purposes subject to their separate privacy policies;
- with third party vendors, consultants and other service providers ("Service Providers") who are working on our behalf and need access to your information to carry out their work for us;
- to (a) comply with laws or respond to lawful requests and legal process, (b) to protect the rights and property of Jakov Apartments, our agents, members, and others including to enforce our agreements, policies and terms of use, or (c) in the good faith belief that disclosure is needed to respond to an emergency or protect the personal safety of any person; and
- in connection with any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company. In any such event, we will provide notice if your data is transferred and becomes subject to a different privacy policy.

This website uses Google AdWords

This website uses the Google AdWords remarketing service to advertise on third party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous visitors who haven't completed a task on our site, for example using the contact form to make an inquiry.
